Policies and procedures

- For children admitted in AY 2019-20, 1st instalment of tuition fee, caution deposit, and imprest deposit must be paid at the time of registration.
- Annual tuition fee instalment must be paid on or before the 10th of the month in which it is due. A discount is given for payment by the 5th of the month.
- If tuition fees are past due, the school will not issue bonafide certificate, performance report, gate pass or hall ticket.
- Fees once paid will not be refunded or transferred under any circumstances.
- Parents are liable for annual tuition fee even if the student withdraws or joins in the middle of the year.
- Payment may be made through cash, cheque, netbanking or credit card.

Caution deposit

Caution deposit of Rs 5000 is collected at the time of registration (only for those admitted in AY 2019-20 onwards). It will be returned as long as there are no fees due or damages. Caution deposit <u>cannot</u> be adjusted against fees; it will only be paid out <u>after</u> dues are cleared. It is separate from imprest and there will be no transactions except after withdrawal.

Imprest deposit

Imprest deposit of Rs 1000 is collected along with the first instalment. The objective is to avoid the inconvenience of

repeated small cash transactions between parents and the school. The school will provide actual expense details on the fee payment dates. Remaining balance if any will be carried forward to next academic year. Imprest balance must be maintained at Rs 500 or above at all times. Imprest deposit covers expenses such as:

- Transport costs and registration fees for <u>optional</u> competitions or events
- Stationery items
- Library fines or fines for late pick up of children as explained in the diary
- Replacement of property that is damaged
